### **NEXT PARISH COUNCIL MEETING**

This will be held on Monday 17<sup>th</sup> April at 6.30 pm in the Nelson Memorial Hall. Everyone is very welcome to attend.

## STREET LIGHTING

Two contractors have given quotes for a new light on the corner of Lowes Lane and Church Lane. It was agreed that more information regarding the specification of the lights would be needed to allow the Parish Council to look at how they want to proceed with this and to enable any application for grants.

Highways would also be asked if it was possible to have a single white line placed on the edge of the road along key areas in the parish to assist giving separation between cars and pedestrians walking on the road.

## ALLOTMENTS AND MILLENNIUM PIECE

The Advisory Group met with Holkham Estate for a walkabout the parish. No updates on Millennium Piece and the allotments have been given by Holkham so it was decided to write to Holkham to ask about these matters as well as chasing with regards to the hedgerows and trees. Holkham will be invited to attend the next meeting with plans for 6 Walsingham Road development.

### OLD RAILWAY LINE TO BURNHAM MARKET

Several forms have been received as evidence of walking the Old Railway Line. It was agreed to delay sending the forms to Norfolk County Council until the middle of April.

## **HIGHWAYS**

It was agreed at the meeting to ask Highways to clean the grips out along Walsingham Road towards Holkham. Unfortunately, Highways have reduced the cleaning of the grips around the parish. Please could public inform the Clerk if they notice any which are full of water or need clearing of rubbish.

## CHERRY TREE ON MILLENNIUM PIECE

The Parish Council agreed to write to the Borough Council asking if this tree could have a Tree Preservation Order placed on it due to local amenity value.
